



Prior to my arrival to the scene, Central Dispatch Center (CDC); stated a traffic crash had occurred between a white Chevrolet Avalanche, this vehicle is referred to as vehicle two (V2) in this report and a brown Oldsmobile Intrigue, this vehicle is referred to as vehicle one (V1) in this report. CDC advised the vehicles moved from the roadway and currently in the parking lot of Price Cutter.

Upon my arrival I spoke with the driver of V1, identified by her Missouri driver license as Kemberleigh Kimble. Ms. Kimble stated she was traveling north on Neosho Boulevard in the inside lane. She said a black Jeep Wrangler pulling a trailer, (this vehicle will be referred to as Vehicle A (VA) in this report), was traveling north on Neosho Boulevard in the outside lane beside her. She said VA started switching to her lane, so she slammed on her brakes to prevent VA hitting her. She said when she slammed on her brakes her car slid to the left and struck V2 in the passenger rear side of the truck bed.

I spoke with the driver of V2, identified by his Missouri driver license as Leslie Shreiner. He stated he was stopped on Neosho Boulevard getting ready to turn onto Johnson Drive. He said the next thing he knew V1 struck him in the passenger side rear of the truck bed.

I spoke with the driver of VA, identified by his Missouri driver license as Dustin Matthews. Mr. Matthews said he was driving north on Neosho Boulevard on the outside lane. He said he went to switch to the inside lane. He said he did not see V1 in the inside lane but heard tires squealing when he went to make the lane switch and realized he caused V1 and V2 to crash.

VA is as follows: Missouri registration #PM7F2V / VIN #1J4FA39SX5P356199 / Progressive Insurance #10233510.

Based on all the driver statements VA had a probable contributing circumstance of improper lane usage/change.
