

On November 8, 2016, I responded to the intersection of W. Daugherty Road and S. Neosho Boulevard in reference to a report of a traffic crash.

Upon my arrival I spoke to both parties and both individuals denied needing any medical treatment. I observed a black Toyota Camry with Missouri license WK5T7W (Vehicle 2) and a white Ford Crown Victoria with Missouri license CA5G2D (Vehicle 1).

I spoke to driver 1 (Loran Clark) and he advised me that he was turning from Neosho Boulevard onto Daugherty Road when vehicle 2 ran into the side of his car while he was turning. I observed the damage to his vehicle and it consisted of damage to the driver side front bumper and the damage continued down the side of the vehicle ending around the passenger door.

I spoke to driver 2 (Alicia Cooper) and she stated that she was sitting at the stop sign on Daugherty Road waiting to go across Neosho Boulevard when she saw the white car starting to make the turn from Neosho Boulevard onto Daugherty Road. Ms. Cooper stated that she honked her horn because she could see vehicle 1 was going to hit the front of her car. Ms. Cooper reported that the vehicle 1 then turned into the front of her vehicle and proceeded to drive on past her vehicle before pulling over behind her vehicle. The damage to Ms. Cooper's vehicle consisted of damage to her front bumper and front driver side head light area.

Mr. Clark's vehicle had a flat front driver side tire and a family member of his responded to change the tire for him. Both vehicles were released at the scene.
